### **RESOLUTION OF LUDINGTON CITY COUNCIL TO AMEND CHAPTER 8, SECTION 8.2 OF THE LUDINGTON CITY CHARTER TO CHANGE THE TIME FOR THE CITY MANAGER'S PRESENTATION OF A BUDGET PROPOSAL AND TO REPEAL ALL RESOLUTIONS IN CONFLICT HEREWITH**

BE IT RESOLVED, by the City Council of the City of Ludington, Michigan, as follows:

1. By a 3/5 vote of its members, pursuant to the authority granted by Public Act 279 of 1909, as amended, it is proposed that Chapter 8, Section 8.2 of the Charter of the City of Ludington shall be amended to read as follows:

Proposed Section 8.2. – Submission of Budget and Budget Message: The City Manager shall prepare for Council a budget proposal and an accompanying message for the next fiscal year, which shall be presented to the City Council for its approval no later than the second Council meeting in November.

The existing Chapter 8, Section 8.2 of the Charter of the City of Ludington to be altered by such proposal, if adopted, now reads as follows:

Existing Section 8.2. – Submission of Budget and Budget Message: The City Manager shall prepare for Council a budget proposal and an accompanying message for the next fiscal year, which shall be presented to the City Council for its approval no later than the first Council meeting in November.

2. The purpose of the proposed amendment shall be designated on the ballot as follows:

This Charter Amendment is proposed for the purpose of changing the time for the City Manager's presentation of a budget proposal and accompanying message from the first Council meeting in November to the second Council meeting in November.

3. The City Clerk shall transmit a copy of the proposed amendment to the Governor of the State of Michigan for approval, and transmit a copy of the foregoing statement of purpose of such proposed amendment to the Attorney General of the State of Michigan for approval, as required by law.

4. The proposed amendment shall be submitted to the qualified electors of this City at the Special Election to be held in the City of Ludington on the 2nd day of AUGUST, 2016, and the City Clerk is directed to give notice of the election and notice of registration in the manner prescribed by law.

*On the Shores of Lake Michigan*

5. The proposed amendment shall be submitted to the electors in the following format:
